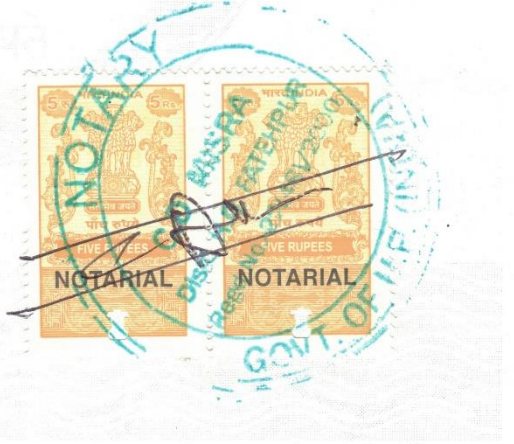
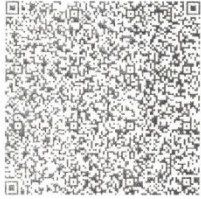

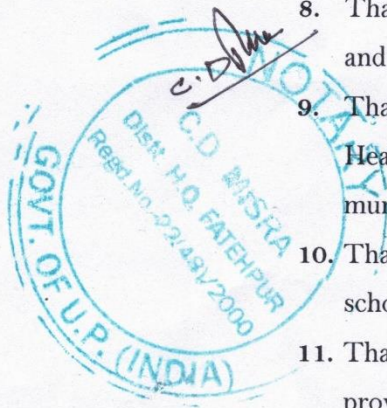
1. That Varanasi Province of Indian Missionary Society is a registered Society / Trust under the **1860 Societies Registration Act**.

14. That the school shall strive to make efforts for conservation of environment.

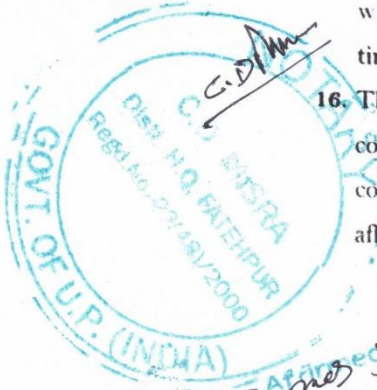
